Rules

1. 4 Members per team. All players must start with one hand on the fence.
2. No players may use gloves, spikes, hooks or any other object to catch the hog.
3. Hogs must be put in the barrel butt first.
4. No hitting hog to stun or otherwise harm the animal.
5. Barrel must be upright at all times.
6. There will be a one minute time limit for each match.
7. All players must raise both hands in the air to complete the time.
8. Players must stay and help unload hog out of the barrel.
9. Judges' rule is final.
10. Youth (8 and under) May be co-ed. There will be No Calcutta for the youth.
11. Calcutta will be at 6:00 p.m.
12. No out of county teams.

Limit: 8 teams in All Divisions. Calcutta will start at 6:00 p.m. The 8 teams in the youth division will not participate in the Calcutta.

All contestants must sign a release form along with a completed entry form, and return it to the Fremont County Fair Office, by the entry deadline. Fees must accompany form. Please make checks payable to: Fremont County Fair.

I further agree to indemnify the Fremont County Fair and its employees and officers, and Double D Livestock, LLC and its officers and employees, from any loss, liability, damage or cost PARTICIPANT may incur due to the presence of PARTICIPANT in or upon the areas where the hog wrestling activities will take place, whether caused by negligence of the Fremont County Fair, Double D Livestock, LLC, or otherwise.

I expressly agree that this release, waiver, and indemnity agreement shall be construed to be as broad and inclusive as permitted by the laws of the State of Wyoming and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.

I expressly understand that the hog wrestling activities involve an inherent risk of injury to oneself and to others and agree to assume this risk on behalf of myself or the participating minor child.

I further understand that the Fremont County Fair and Double D Livestock, LLC are not liable for the injuries to those who participate in the hog wrestling and related activities, nor to audience members, observers, or any others present.
